# FREQUENTLY ASKED QUESTIONS/ TERMS AND CONDITIONS OF PURCHASE

## Q1. WHERE IS URBAN GARDEN, ONITSHA?

A URBAN GARDEN, ONITSHA is an undeveloped parcel of land located at the five naira junction Second Niger Birdge, Onitsha Anambra State

## Q2. WHO ARE THE OWNERS/DEVELOPERS OF URBAN GARDEN, ONITSHA?

A PWAN MAX, a Leading Real Estate Company with offices in Awka, Anambra State, Asaba, Delta State, Owerri Imo State, Portharcourt Rivers State, Lekki, Lagos State.

## Q3. WHAT TYPE OF TITLE DOES URBAN GARDEN, ONITSHA HAVE ON THE LAND?

A Registered Survey & Deed of Assignment.

## Q4. ARE THERE ANY ENCUMBRANCES ON THE LAND?
